### **TOWN COUNCIL SUMMARIZED MINUTES**

#### **1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE**

Mayor Bryan called the meeting to order at 5:06pm and the Pledge of Allegiance was recited.

#### **2. ROLL CALL**

#### **3. DISCUSSION OF DRAFT LANGUAGE FOR THE TUSAYAN MUNICIPAL CODE**

##### **A. Chapter 11 – Offenses (continued)**

Manager Tami Ryall gave a brief overview of a previous Workshop which began this discussion of Offenses. She distributed an Offense Penalty Matrix showing offense types and associated penalties. The maximum penalties have been prescribed by Arizona Statute. The Council compared offenses and penalties as they went through the list and assigned penalties to offenses which had not been covered in previous meetings.

Manager Ryall reviewed previous discussions on Chapter 11. Then she and the Council had discussions on the following sections and made the associated changes:

- Section 11-1-6 – Alcohol Use on Town Property. The Council removed the limit of 3 times per year for issuing permits. They also excluded residential areas of Town-owned housing from this prohibition.
- Section 11-1-7 – Signs and Banners on Town Property – The Council reduced the penalty to a Class 3 Misdemeanor.
- Section 11-1-8 – Unsafe Buildings or Structures – no changes
- The Council decided to list the penalty for each offense in each section.

- Section 11-1-10 – 911 Emergency Telephone Number System False Reporting – no changes
- Section 11-1-12 – False Alarms – the Council requested Ms. Ryall to research how a malicious act of creating a false alarm will be covered. They also added a clause stating that repeated offenses at a single location may become a Class 2 Misdemeanor if they occur more than 4 times in 12 calendar months.
- Section 11-1-13 – Sale of Pseudo-ephedrine Products – The Council decided to remove the contents of this Section and reserve it for future use.
- Section 11-2 – Fireworks – The Council requested Ms. Ryall to research:
  - Whether the Town has the ability to prohibit the sale of fireworks
  - What the law states for other Northern Arizona towns and cities, Coconino County, and the State
  - Enforcement
- Ordering and numbering errors will be corrected.
- Section 11-1-1 – Dangerous Constructions – The penalty will be changed to a Class 2 Misdemeanor.
- Sections 11-1-3 – Minors; Curfew; Liability of Parent and 11-1-4 – Loitering - The penalty will be changed to a Class 3 Misdemeanor.

**4. MOTION TO ADJOURN**

Vice Mayor Montoya made a motion to adjourn the meeting at 6:41pm. Councilmember Rueter seconded the motion and it passed on unanimous vote.
