### **TOWN COUNCIL SUMMARIZED MINUTES**

#### **1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE**

Meeting was called to order by Mayor Sanderson at 4:35pm and the Pledge of Allegiance was recited.

#### **3. DISCUSSION OF ITEMS**

##### **A. FY 2016-17 Budget discussion: Tusayan Fire District (TFD) subsidy**

TFD Chief Greg Brush presented information to the Council regarding the services provided by the TFD to the Town of Tusayan and the surrounding area and the financial difficulties of the District and Fire Districts across the nation. He also presented the TFD Five Year Plan.

The Council discussed issues and options with Chief Brush and TFD Board Member John Vail.

##### **B. Flood Plain Administration options**

Manager Duthie stated that he previously made a recommendation for the Town to keep the Coconino County Flood District as the Flood Plain Administrator for the Town of Tusayan. He has since met with County Officials and learned about issues which have changed his mind and now recommends the Council approve the Town taking over Flood Plain Administration within the Town.

Clarinda Vail, on the behalf of Bess Foster, John Thurston, Red Feather Properties, and herself (land owners in Tusayan), spoke to the Council in opposition to the Town becoming the Flood Plain Administrator. She stated that she has had no issues with Coconino County, even in getting changes made to FEMA maps. She asked if the flood study funded by the Town is complete and when it would be made public. Manager Duthie stated that it is his belief that the study is not complete due to a point of contention with the County Flood District over flow rates.

The Council discussed options concerning Flood Plain Administration.

The feasibility study has been completed and has been submitted to Commnet but is not yet available to us. Manager Duthie and Vice Mayor Rueter will be meeting with Commnet on Monday.

## **7. ACTION ITEMS**

### **A. Consideration, discussion, and possible approval of CDBG project ribbon-cutting**

Manager Duthie stated that the CDBG project is 99.9% complete and is ready for a ribbon-cutting. The regional representative for NACOG will be here for a pre-audit in a few weeks and the State Housing Authority will be here for the audit in June.

Mayor Sanderson made a motion to have the ribbon-cutting on Thursday, May 5, 2016, at 5:30pm. Vice Mayor Rueter seconded the motion and it was approved on unanimous vote.

### **B. Consideration, discussion, and possible approval of Resolution 2016-03 and Ordinance 2016-01 (Town of Tusayan Subdivision Code)**

Manager Duthie stated that a clean copy of the Code is in the packet, as well as pages containing highlighted modifications which have been made since the Council last reviewed the document. He reviewed each change with the Council. He also stated that staff and the Planning and Zoning Commission have recommended approval. He noted that the Commission has appointed Rob Gossard as Chair and he is here.

Vice Mayor Rueter made a motion to approve Resolution 2016-03 and Ordinance 2016-01 (Town of Tusayan Subdivision Code). Councilor Montoya seconded the motion and it was approved on unanimous vote.

### **C. Consideration, discussion, and possible approval of Flood Plain Administrator designation**

Chris Thurston and John Thurston submitted notes in opposition to the Town becoming the Flood Plain Administrator. Clarinda Vail spoke in opposition and asked the Council to consider the liability which would move to the Town, to remember that the Sanitary District treatment plant is at the end of the flood plain in Town, and asked if the Council has read the Arizona State Statutes on this topic.

Vice Mayor Rueter stated that he is familiar with the state statutes and is in favor of making the Town the administrator.

Vice Mayor Rueter made a motion to designate the Town of Tusayan as the Flood Plain Administrator for the Town. Councilor Montoya seconded the motion.

The Council discussed the motion and it was approved on unanimous vote.

Manager Duthie noted that he would begin the process to transfer this responsibility to the Town from the Coconino County Flood District.

**D. Consideration, discussion, and possible approval of Housing Authority guidelines.**

Councilor Wirth stated that she'd like to come up with a catchy name for the event and make it an annual event. The idea is to have local businesses participate in working on the right-of-way in front of their own businesses and then the Council will donate and cook dinner for the participants.

Clarinda Vail stated that a photographer for the Chamber of Commerce will be in Town May 23-25<sup>th</sup> so this will be good timing.
