**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF
TUSAYAN, COCONINO COUNTY, ARIZONA, DECLARING AND ADOPTING
THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 6,
2018.**

WHEREAS, the Town of Tusayan, Coconino County, Arizona, did hold a General Election on the 6th day of November 2018 to vote on the extension of the Town's Alternative Expenditure Referendum (Home Rule); and, a run-off election to decide a tie vote in a council race originally held on August 28, 2018:

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Tusayan, Coconino County, Arizona, as follows:

Section 1. That the total number of votes cast at said General Election, as shown by the Coconino County Election Summary Report, was **137** in the Alternative Expenditure Limitation (Home Rule) referendum, and **136** for the Council run-off.

Section 2. That the votes cast at the General Election were as follows:

To extend the Alternative Expenditure Limitation (Home Rule)- Town of Tusayan:

YES- 73
NO- 64

COUNCIL RUN-OFF- Town of Tusayan


Robb Baldosky- 69
David Chavez- 62

Section 3. As to the Alternative Expenditure Limitation (Home Rule) referendum, the YES votes comprised a majority of the votes cast; therefore, the Alternative Expenditure Limitation (Home Rule) is extended for a period of four years in the Town of Tusayan.

Section 4. As to the Council run-off election, Robb Baldosky received a sufficient majority of the votes cast, and is elected to a four-year term on the Tusayan Town Council.




