

RESOLUTION NO.2020-14

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF TUSAYAN, COCONINO COUNTY, STATE OF ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 4, 2020

WHEREAS, the Town of Tusayan, Coconino County, Arizona did hold a primary election on the 4th day of August 2020 for the nomination/election of Mayor and two Councilpersons.

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Tusayan, Coconino County, Arizona, as follows:

SECTION 1. That the total number of ballots cast for candidates on the ballot for the offices of Mayor and two Council members at the primary election on August 4, 2020 was 143.

SECTION 2. Town of Tusayan Ordinance No. 2010-04-20-01 provides that any candidate who receives at the primary election a majority of all the votes cast shall be declared to be elected to the office for which the candidate is running as of the date of the general election.

SECTION 3. That the votes cast for the candidates for Mayor and Councilmembers were as follows:

SECTION 4. That it is hereby found, determined, and declared of record, that the following candidates did receive a majority of the total number of votes cast as required by Town of Tusayan Ordinance No. 2010-04-20-01 for the respective offices set forth below and are hereby issued certificates of election:

(i) Clarinda Vall – Mayor and (ii) Rebecca Wirth – Councilmember. These candidates who have received a majority votes cast as determined by Town of Tusayan Ordinance No. 2010-04-20-01 for the respective offices for which were candidates shall be elected to the office for which they are a candidate as of the date of the November 3, 2020 General Election.

SECTION 6. In accordance with Town of Tusayan Ordinance No. 2010-04-20-01 the following candidates shall be placed on the ballot for the November 3, 2020 General Election as candidates to fill one Councilmember position on the Town of Tusayan Town Council: (i) Greg Brush and (ii) Joshua Collet.


SECTION 7. This resolution shall be in full force and effect upon its adoption.
