

RESOLUTION NO. 2022-07

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF TUSAYAN, ARIZONA, PROVIDING NOTICE OF THE PURPOSE AND DATES OF THE PRIMARY ELECTION AND GENERAL ELECTION; DESIGNATING THE CONDUCT OF ELECTIONS; PROVIDING NOTICE OF THE DEADLINE FOR VOTER REGISTRATION; DESIGNATING THE METHOD AND PLACES OF VOTING; AND PROVIDING NOTICE OF THE DEADLINE TO CANVASS ELECTION RESULTS.

WHEREAS, Ariz. Rev. Stat. §§ 9-821.01 and 16-204 (F) authorizes the Town of Tusayan ("Town") to hold its Primary Election on the first Tuesday in August in an even-numbered year and if necessary, a Runoff or General Election on the first Tuesday after the first Monday in November in an even-numbered year.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF TUSAYAN, ARIZONA, as follows:

SECTION 1. Designation of Election Dates. Pursuant to Ariz. Rev. Stat. § 16-204 (F), the Primary Election shall be held on August 2, 2022, for the purpose of nominating candidates for the offices of Mayor (one seat for a 2-year term) and Council Members (two seats for a 4-year term). Any candidate receiving a majority of votes cast pursuant to Ariz. Rev. Stat. § 9-821.01 will be declared elected without running at the General Election on November 8, 2022.

SECTION 2. Conduct of Election; Expenditures. The elections will be conducted as determined by Coconino County. The Primary Election may be consolidated with any other election in the Town on August 2, 2022 and the General Election, if held, may be consolidated with any other election in the Town on November 8, 2022. The Town is hereby authorized to request the Coconino County Elections Department have ballots printed with the names of eligible candidates and to deliver them to the election officials to be given to the qualified electors of the Town appearing to vote in the Primary Election as provided by law. The Town authorizes all expenditures as may be necessary to order, notice, hold and administer the Primary and General Elections ("Elections"), including without limitation, the cost of return postage to return the voted mail ballots, which expenses shall be paid from current operating funds of the Town. The Town may enter into an intergovernmental agreement with Coconino County to conduct the Elections.

SECTION 3. Deadline for Voter Registration. Coconino County registration and voting lists will be used for the Elections. A voter in these Elections must be a qualified elector of the Town, which is defined as a person who is registered to vote and whose name appears on the Coconino County voter registration rolls within the boundaries of the Town twenty-nine (29) days prior to the date of the Elections. To be qualified to vote in the Primary Election, a Town resident must be registered to vote by July 5, 2022. To be qualified to vote in the General Election, if held, a Town resident must be registered to vote by October 11, 2022.

SECTION 4: Early Voting. Early voting will be permitted at the Elections in accordance with the provisions of Title 16, Chapter 4, Article 8, Arizona Revised Statutes, as amended.

SECTION 5. Establishing Polling Places; Voting System. As applicable, the polling places used in the Town will be the polling places established by Coconino County and used for
