

RESOLUTION NO. 2022-15

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF TUSAYAN, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY AND SPECIAL ELECTIONS ON AUGUST 2, 2022.

WHEREAS, the Town of Tusayan, Coconino County, Arizona did hold a Primary Election on the 2nd day of August, 2022 for the election of the Mayor for a two-year term and two (2) Councilmembers for four-year terms; and

WHEREAS, the Town of Tusayan, Coconino County, Arizona did hold a Special Election on the 2nd day of August, 2022 for Proposition 439 relating to the purchase of Hydro Resources, Inc. Water System;

WHEREAS, pursuant to A.R.S. § 9-821, the Town of Tusayan shall canvass the returns, declare the result and issue the certificates of the election or nomination; and

WHEREAS, the Town of Tusayan shall declare elected candidates for Mayor and Town Council pursuant to the statutory calculation formula provided under A.R.S. § 9-821.01; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Town Council.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF TUSAYAN as follows:

SECTION 1. Exhibit A, attached, are the Final Election Results from Coconino County for the Town of Tusayan August 2, 2022 Primary and Special Elections.

SECTION 2. The Votes Cast for the candidates in the office of Mayor were as follows:

SECTION 3. It is declared that candidate Clarinda Vail received the majority of votes cast pursuant to A.R.S. § 9-821.01(D) and is elected to a two-year term as Town Mayor.

SECTION 4. The Votes Cast for the candidates for the two offices of Council Member were as follows:

SECTION 5. It is declared that candidates **David Chavez and Josh Collett** each received the majority of votes cast pursuant to A.R.S. § 9-821.01(D) and are each elected to a four-year term as a Town Council Member.


SECTION 6. The Votes Cast for Proposition 439 relating to the purchase of Hydro Resources, Inc. Water System was as follows:
